# Fair Funding Study Commission Convenes

Representative Jay O'Grady and Representative Gregg Amore are leading a study commission to review the education funding formula and whether or not the formula is fairly and equitably handling charter school funding. RIFTHP President Frank Flynn has been named to the twelve member commission. Also on the commission are representatives of the NEA/RI, Rhode Island Association of School Committees, League of Charter Schools, League of Cities and Towns, MET School, Rhode Island Mayoral Academies, RIDE, and the RI School Superintendents Association.

Chaired by Rep. O'Grady, the Commission will be meeting weekly at 3:00PM on Fridays to examine four topics. He announced the agenda at the initial meeting held on Thursday, January 15, 2015. They will begin with a review of how charter school funding impacts property taxes. Eight witnesses including school superintendents and council members are scheduled to testify at the Friday January 23 meeting. Their next hearing will focus on discerning obligations of the regular school district compared to charter schools such as out-of-district special education costs, transportation costs, private school textbooks, and other programs required of schools

The third area of inquiry will be to examine special education populations at charter schools and compare them to sending school districts. The final topic will be tuition costs paid by districts compared to spending needs of charter schools.

Chair O'Grady has developed an ambitious agenda with the hope of making findings that influence the state budget adopted this session. The hearings are televised on the statewide interconnect for those interested in following the commission activities.

## Bill Introductions

#### **Income Tax - Retirement Income Exemption**

(H5000 Craven, House Finance)

The RIFTHP supports this act which would exempt retirement income from state personal income tax.

#### **Income Tax - Retirement Income Exemption**

(<u>H5055</u> Giarrusso, House Finance)

The RIFTHP supports this act which would exempt retirement income from state personal income tax.

#### **Income Tax - Retirement Income Exemption**

(H5056 Morgan, House Finance)

The RIFTHP supports this act which would exempt retirement and social security income from state personal income tax.

#### Income Tax Credit - Student Loan Debt

(H5086 Blazejewski, House Finance)

The RIFTHP supports this act which would create the Stay Invested in RI Tax Credit authorizing a tax credit against state personal income tax for up to ten (10) years after graduation from an institution of higher education, for graduates who reside and work in Rhode Island.

#### **Distribution of State Surplus**

(H5140 Shekarchi, House Finance)

The RIFTHP opposes this act which would direct fifty percent (50%) of any state surplus to be distributed to the General Fund and the remaining fifty percent (50%) to the cities and towns in accordance with the State Aid Formula instead of placing the surplus into the retirement system.

#### **Mayoral Charter School Approval Process**

(H5160 Serpa, House Health, Education and Welfare)

(S0087 Satchell, Senate Education)

The RIFTHP supports this act which would provide that a mayoral academy charter school's application would not be approved by the Board of Education unless the school committee and the city or town council of each included municipality also supported the application.

#### **Pension Litigation Costs**

(H5169 Hull, House Finance)

The RIFTHP supports this act which would provide that any litigation costs paid from the restricted receipt account for the Retirement Board be limited to defending actions that arise as a result of decisions made by the Board.

### **DSP Rate Increase**

(H5170 Hull, House Finance)

The RIFTHP supports this act which would require the Director of Behavioral Healthcare, Developmental Disabilities, and Hospitals to adopt a state reimbursement system for community and nonprofit agencies that encourages the hiring and retention of competent individuals. This rate will be thirteen dollars and ninety-seven cents (\$13.97) per hour and will be adjusted annually.

## **Public Employee Card Check**

(H5180 Blazejewski, House Labor)

The RIFTHP supports this act which would authorize the Labor Board to certify and recognize union representatives that submit authorization cards signed by seventy percent (70%) of its members. It would also empower the Board to investigate and prosecute coercion by union representatives.
